### **NJ BROKER LICENSING REQUIREMENTS**

- Successful completion of the 90 hour General Broker's Course, the 30 hour Agency and Ethics Course and the 30 hour Office Management Course *(These courses must be completed within a two-year period of time or less)*
- After completion of above courses, the candidate must have the employing Broker(s), for the past three years, complete an experience report(s) to substantiate that the Broker candidate worked full time in the real estate business for the past three years. *(Full time means five days per week from approx. 10 AM to 8 PM and that the candidate had no other employment that exceeded 25 hours per week during the three-year apprenticeship)*
